**\*\*ALL STUDENTS MUST PROVIDE A VALID FLORIDA DRIVERS LICENSE, FLORIDA VEHICLE REGISTRATION, CURRENT INSURANCE CARD, \$70.00 AND APPLICATION FORM.**

1. PARKING IS A PRIVILEGE GRANTED BY THE SCHOOL BOARD OF SEMINOLE COUNTY. ANY STUDENT WHO CHOOSES TO PARK A CAR ON THE SCHOOL CAMPUS DURING HIS OR HER ATTENDANCE AT SCHOOL OR A SCHOOL SPONSORED EVENT CONSENTS TO A SEARCH OF HIS OR HER CAR BY A SCHOOL ADMINISTRATOR WITH OR WITHOUT REASONABLE SUSPICION. STUDENTS ARE ACCOUNTABLE FOR ANY VIOLATION OF THE STUDENT CODE OF CONDUCT, INCLUDING ANY CONTRABAND, SUCH AS: WEAPONS, DRUGS, TOBACCO, PRESCRIPTION OR OVER THE COUNTER MEDICATION, AND/OR ANY ITEM DEEMED INAPPROPRIATE BY ADMINISTRATION.

2. AUTOMOBILES PARKED ON SCHOOL GROUNDS MUST BE REGISTERED WITH THE SCHOOL AND MUST DISPLAY THE CURRENT DECAL. STUDENTS MAY NOT PARK ON KING STREET OR ON THE BUS RAMP. STUDENTS PARKING IN AN UNAUTHORIZED AREA OR ANY OTHER AREA NOT DESIGNATED FOR STUDENT PARKING WILL BE SUBJECT TO TOWING, LOSS OF PARKING PRIVILEGES, AS WELL AS DISCIPLINARY ACTION WHICH INCLUDE THE FOLLOWING STEPS.

- 1. WARNING, PARENT CONTACT**
- 2. SATURDAY SCHOOL OR EQUIVALENT**
- 3. VEHICLE WILL BE TOWED AT OWNERS EXPENSE**

3. RECKLESS DRIVING ON THE SCHOOL GROUNDS MAY RESULT IN IMMEDIATE AND PERMANENT SUSPENSION OF PARKING PRIVILEGES.

4. SECURING A PARKING PERMIT UNDER FALSE PRETENSES FOR ANOTHER STUDENT IS A SUSPENDIBLE OFFENSE AND WILL RESULT IN THE REVOKING OF THE PARKING PRIVILEGES OF ALL PARTIES INVOLVED.

5. UNAUTHORIZED LEAVING OF CAMPUS MAY RESULT IN LOSS OF PARKING PERMIT

6. STUDENTS MUST EXIT THEIR VEHICLES AND THE PARKING LOT IMMEDIATELY UPON ARRIVAL TO SCHOOL. NO STUDENT IS ALLOWED IN ANY PARKING AREA DURING THE SCHOOL DAY WITHOUT A PASS.

8. STUDENTS MUST REMAIN IN COMPLIANCE WITH THE OHS ATTENDANCE POLICY OR WILL RISK REVOCATION OF THEIR PARKING PERMIT.
